

CALIFORNIA INGREDIENT DISCLOSURE

Covered products include air care prodcuts, automotive products that maintain the appearance of a motor vehicle, general cleaning products, or polishes or floor maintenance products used primarily for janitorial, domestic, or institutional cleaning.
